Treasurer's report: Nick Nichols for Ken Meigs [Ken was available via ZOOM for anyone who wanted to ask questions]

- Financial books are open to any Association member to view. Send your request to Ken.
- The Association is very solvent. Current balance is: **\$11,608.31**
- The account is divided into 3 funds IAW the bylaws:
 - Operational Fund: **\$8,108.31**
 - Reunion Fund: **\$0.00**
 - Charity Fund: **\$3,200.00**
- Via ZOOM, Ken discussed the reason the reunion fund is at \$0. As prices go up, reunion committees are requiring more seed money to work with the hotels and vendors setting up the reunion. - A motion was passed last reunion stating the Henry L. Stimson Association recognizes the Henry L. Stimson Facebook Page is the official FB page of the Association.
- There are 4 administrators to manage the page: Derek Lyons; Ray Varkalis; Glen Clark; Loree Riggs
- After contact with the administrators I can report the page is running smoothly.
- As a refresher for those who were not here last reunion, the Association guidelines the Administrators use are:
 - This is a closed private page and you must be approved to post anything. To get approved to have access contact the administrator.
 - Criteria: 1) must be a shipmate and able to document it; 2) spouses of departed members; 3) direct family members
 - Verification methods: 1) check requesters page for any submarine association; 2) check 655 Sailing List for name and then approved if on there; 3) if no documentation then they receive a note showing reason for asking access and they must send email to webmaster with info to be added to sailing list; 4) if they do not respond to be added they will not be given access to the 655 FB page.
 - Posts are limited to one that is directly related to 655. If not related the post is deleted and the admin that deletes it will contact the one that made the post.
 - No Ads, nothing to be sold on our FB page
 - No Politics
 - No bad language
 - No dirty/inappropriate cartoons
- The FB page is used to promote the Reunion.

Old Business:

- **Stimson Bench at the Cold War Memorial - Nick Nichols**

- Stimson Bench and other benches at the Cold War Memorial in Charleston are physically maintained by the Patriot Point Authority.
- A couple times each year, Charleston Base and individual submariners will clean the CWM area or individual benches.
- The Cold War Memorial Maintenance and Preservation Fund (CWMM&P) was established to provide funding for cleaning the benches with many submarine groups proving funds.
- The CWMM&P fund is maintained by USSVI Charleston Base Treasurer and money only issued for maintenance and cleaning of the CWM area.
- Past reunions have donated to this fund when requested. This year no request is being made for a donation.

New Business

- **Election of 2023-2025 Officers:**
 - The bylaws list the responsibilities for the elected Board of Directors members.
 - Current President, Tom Krauser, is not running for another term.
 - Nomination for President:
 - Jerry Blevins has been nominated.
 - There were no other nominations. Jerry was elected unanimously.
 - Nomination for Vice-President:
 - Ray Kreul volunteered for the position. Ray was elected unanimously.
 - Current Treasurer, Ken Meigs, has agreed to remain as Treasurer.
 - There were no other nominations. Ken was elected unanimously.
 - Current Secretary, Nick Nichols, has agreed to remain as Secretary.
 - There were no other nominations. Nick was elected unanimously.
 - Officers for the 2023-2025 term will take office at the completion of the reunion:
 - President – Jerry Blevins
 - Vice President – Ray Kreul
 - Treasurer – Ken Meigs
 - Secretary – Nick Nichols

- **Donation:** The Board moves to donate \$1000 from the Charity Fund to the St. Mary's Submarine Museum to assist them with their building fund.
 - DISCUSSION: The Museum already houses several pieces of Stimson artifacts and has agreed to receive whatever historical items we have when the Association is dissolved IAW the bylaws.
 - Motion seconded: David Huckeba
 - Motion passed with 1 opposed

- **Bylaw Revision/s:**
 - We will be voting on an extensive rewrite to the bylaws
 - 90% of the rewrite is strictly reformatting but there are some proposed changes.
 - All shipmates who are attending this reunion were emailed copies on September 7, 2023 of the PROPOSED CHANGES TO THE STIMSON ASSOCIATION BYLAWS with copies of the current and proposed changes as attachments. You were asked to review and comment prior to the reunion.
 - Only two shipmates responded to the request for comments. These changes were reviewed and wording/punctuation changes were completed. None of these minor changes changed the intent or the bylaws in any significant manner.
 - The Board motions the bylaws revision/changes be approved as received by the reunion attenders.
 - President asks for questions/comments.

- Tom Bradish spoke from the floor concerning Article I.C.1. concerning Membership Eligibility.
- Tom made a motion to have this article read as follows:
 - All shipmates of the USS Henry L. Stimson (SSBN 655) and their families are members of the Association. An Officer of the Association may appoint others with interest in the Association as Honorary Members.
 - Motion was seconded by UNKNOWN
 - Motion was passed unanimously.
- Tom Bradish spoke from the floor with comments on Article III.1.c.
- There was considerable discussion by many members concerning Tom's comments and purpose of this article.
- Paul Clark made a motion to leave Article III.1.c. as written with no changes.
 - Motion was seconded by David Huckeba.
 - Motion was passed with 2 opposed.
- President called for a vote on the revised bylaws as changed by the vote above.
 - Bylaws were approved as the motion passed unanimously.
- **2025 Reunion Location & Chairman**
 - Proposed 2025 Reunion Locations & Chairman were requested in the August, September and October newsletters, and by other emails sent to all Association members by the Secretary prior to this reunion.
 - John Glaub proposed Groton CT for the 2025 Reunion. John & Gretchen volunteered to co-chair the reunion.
 - A vote by show of hands indicated the 2025 reunion will be held in Groton CT with John & Gretchen Glaub as the Co-Chairman.
They received a very welcome round of applause and many comments about great to be going back to Groton.
